

Terms & Conditions

1. Each PALS will be entitled to two (2) complimentary movie tickets upon successful registration.
2. Registration priority will be given to PALS who have not participated in the previous movie night.
3. **Collection of tickets will be on event day as follows:**

Time: 8:00pm – 8:45pm
Venue: TGV Cinemas, Sunway Velocity Mall.
Sunway Property reserves the right to release the uncollected tickets after 8:45pm on 27 October 2017.
4. **Registered PALS is required to present MyKad identification card (for Malaysian) or Passport (for Non-Malaysian) for verification purpose during the collection of tickets on event day.**
5. **In the case of third party collection of tickets, a screenshot of MyKad identification card (for Malaysian) or Passport (for non-Malaysian) of the registered PALS are required for verification purpose. Sunway reserves the rights to withhold tickets which are without proper authorization.**
6. Seats are pre-arranged or allocated based on the time of registration or at the discretion of the organizer. No changing of seats is allowed.
